DIRECTOR'S ORDER UNDER SECTION 157 OF THE FAIR TRADING ACT

TO

TILER TECH INC., MARCO ANTONIO CORAZZA, CALVIN TYLER FENWICK

AND TO

ANY EMPLOYEE, REPRESENTATIVE, OR AGENT OF TILER TECH INC., MARCO ANTONIO CORAZZA OR CALVIN TYLER FENWICK

ISSUE

Marco Antonio Corazza and Calvin Tyler Fenwick are directors of the corporation Tiler Tech Inc., doing business under the trade name Tiler Tech. Between August 21, 2014 and October 25, 2014 Calvin Fenwick or a representative of Tiler Tech negotiated and or concluded prepaid contracts with three different consumers for renovations to be done on consumer residences in Edmonton, Alberta. The contracts were either negotiated or concluded in person at the consumer's residences. Deposit and or progress payments were requested and or accepted by Calvin Tyler Fenwick, Marco Antonio Corazza or a representative of Tiler Tech before all work was completed.

This activity constitutes a "prepaid contracting business" requiring Tiler Tech Inc., Marco Antonio Corazza, and or Calvin Tyler Fenwick to be licensed under section 104(1) of the Fair Trading Act.

At the time of entering into prepaid contracts with these consumers Tiler Tech Inc., Marco Antonio Corazza and or Calvin Tyler Fenwick were not licenced as a Prepaid Contracting Business as required under section 104(1) of the *Fair Trading Act*.

A "Prepaid Contracting Business" means the activities of soliciting, negotiating or concluding in person, at any place other than the seller's place of business, a Prepaid Contract.

A "Prepaid Contract" means a construction or maintenance contract in which all or part of the contract price is to be paid before all of the goods or services called for in the contract are provided. A "Construction or Maintenance Contract" in part means a contract for the purposes of constructing, altering, maintaining, repairing, adding to or improving a person's own private dwelling or a structure / building located on the same property, used in conjunction with the person's own private dwelling or improving real estate property to be used in connection with the person's own private dwelling / building / structure.

ORDER

- Tiler Tech Inc., through any employee, representative, agent or associate must immediately stop engaging in the activities of a Prepaid Contracting Business, by soliciting, negotiating or concluding in person, at any place other than the seller's place of business, a prepaid contract until licensing has been obtained.
- Marco Antonio Corazza and Calvin Tyler Fenwick, individually, as an agent or director of Tiler Tech Inc., or through any employee, representative, agent or associate must immediately stop engaging in the activities of a Prepaid Contracting Business, by soliciting, negotiating or concluding in person, at any place other than the seller's place of business, a Prepaid Contract until licensing has been obtained.

NON COMPLIANCE WITH ORDER

 ANY PERSON WHO FAILS TO COMPLY WITH AN ORDER OF THE DIRECTOR UNDER SECTION 157 OF THE FAIR TRADING ACT CONTRAVENES THIS ACT AND IS GUILTY OF AN OFFENCE AND MAY BE PROSECUTED PURSUANT TO SECTION 163 OF THE FAIR TRADING ACT.
